### AFFIRMATION AND LIABILITY RELEASE

I, \_\_\_\_\_ hereby affirm that I have been well advised and thoroughly informed of the inherent hazards of skin diving and scuba diving. Further, I understand that diving with compressed air involves certain risks, and injuries can occur that requires treatment in a recompression chamber. I further understand that the open water diving trips may be conducted at sites that are remote, either by time or distance or both, from such a recompression chamber, and nonetheless agree to proceed with such dives. I hereby personally assume all risk in connection with said trips for any harm injury, or damage that may befall me as a result of my participation in these trips in spite of the possible absence of a recompression chamber in proximity of the dive site. I understand and agree that neither the DIVE MASTER nor SEA QUEEN FLEET, EGYPT may be held liable in any way for any occurrence in connection with these diving trips that may result in injury, death or other damages to me or my family, heirs or assigns, and in consideration of being allowed to enrol in these trips, I hereby personally assume all risks in connection with said trips, for any harm, injury, or damage that may befall me while I am enrolled in these trips, including all risks connected therewith, whether foreseen or unforeseen; and further to save and hold harmless said persons for any claim to me, or my family, estate heirs, or assigns, arising out of my enrolment and participation in these diving trips. I further state that I am of lawful age and legally competent to sign this affirmation and release, or that I have acquired the written consent of my parents or guardians; that I understand the terms herein are contractual and not a mere recital; and I have signed this document of my own free act. It is the intention of \_\_\_\_\_ by this instrument to exempt and release the DIVE MASTER AND/OR SEA QUEEN FLEET, EGYPT from all liability whatsoever for personal injury, property damage or wrongful death caused by negligence.

### BOAT REGULATIONS

The dive guide/ manager is the only person in charge on the boats/ on land. His or her briefing & instructions must be followed. All dives are no-decompression dives though a safety stop is recommended. The maximum depth is 40 meters. Pressure and depth gauges, BCD`s are mandatory. It is strictly forbidden to dive alone i.e.: without a buddy. Tanks are not to be completely emptied, ascend at 30-50 bars. Establish positive buoyancy at the surface. Ascend from a drift dive along side the reef not in the blue. No shallow diving directly underneath the boat. Never ascend underneath the boat; use a mooring line to avoid accidents resulting from an emergency rotation of the propeller. Only one diver should be on the ladder at the time and no one underneath, also be careful not to have your fingers stuck between the hinges of the ladder. Do not enter the water without checking first with the dive guide that it is safe to do so. It is strictly forbidden to dive after consuming alcohol. A minimum of 20 logged dives is required for Ras Mohammed and the wreck of the Thistlegorm. Rules on our dive-sites: No touching or collecting corals, shells or objects underwater. No fish feeding or spear fishing is allowed. Photographers should be particularly careful not to touch corals or rearrange objects underwater to take a picture, do not wear gloves and no fishing.

### EQUIPMENT LIABILITY RELEASE

I am perfectly aware that this is my own responsibility to check any equipment I rent from **SEA QUEEN FLEET**. In the unfortunate case of loss or damage of equipment rented from the club, I agree to pay to **SEA QUEEN FLEET** the cost as per price list available at SCUBA DIVERS RED SEA, Sharm el Sheikh. I have examined the equipment and find it all in good working order and I certify that I am properly trained in its use. I further hold harmless **SEA QUEEN FLEET** and its agents from any accidents occurring during the use of said equipment.
